**A. HAZARDOUS MATERIALS RESPONSE AND ABATEMENT FEES**

1. Costs for mitigating an incident involving a hazardous materials spill. Standby fee for the protection of life, property and the environment during a potentially dangerous act involving hazardous materials.

a. Equipment – staff vehicle	\$18
b. Equipment – utility vehicle	\$25
c. Equipment – 4X4	\$25
d. Equipment – pumper (engine)	\$95
e. Equipment – tanker	\$50
f. Equipment – aerial ladder	\$175

h. Equipment – boat	\$70

2. Breakdown by rank\*:

- a. Division Chief/Fire Marshal
- b. HazMat Manager

\* Hourly billing rates are based on the cost of delivering the services, including direct costs such as salaries and benefits (at step E), maintenance and operations costs, and indirect costs such as accounting, data processing, and insurance. (Example: Hourly salary and benefit rate, plus maintenance and operations expense calculated as 25% of the hourly salary and benefit rate, plus indirect costs calculated as 20% of the hourly salary and benefit rate. [\$50.00, plus \$12.50, plus \$10.00 equals \$72.50 service fee].)

**B. STORAGE FEE**

The cost of storing hazardous materials at or above fire permit levels within the City limits.

**C. SERVICE FEE**

Service fees will be charged for services provided to organizations or persons who require the expertise of Hazardous Materials Program personnel. Service fees will be charged on an hourly basis.

\*Hourly billing rates are based on the cost of delivering the services, including direct costs such as salaries and benefits (at step E), maintenance and operations costs, and indirect costs such as accounting, data processing, and insurance. (Example: Hourly salary and benefit rate, plus maintenance and operations expense calculated as 25% of the hourly salary and benefit rate, plus indirect costs calculated as 20% of the hourly salary and benefit rate. [\$50, plus \$13, plus \$10 equals \$73 service fee].)
